- Application for re-evaluation on the prescribed form along with the fee should reach the
  controller of the examination within 15 days from the date of declaration of the result of
  the candidates. No application shall be entertained after the due date
- The candidates are allowed to apply for re-evaluation in either of the papers i.e A or B of the subjects or both together. In case of Chemistry subject in Bsc. Examination, reevaluations allowed either in paper I,II,III or in three papers taken together.
- Re -evaluation shall be permissible up to the maximum of 50% of the courses/subjects
  prescribed for a particular programme /course provided the candidate is falling in course s
  or a subjects by 10% or less .in case of the odd number of courses in a programme /course
  0.5 shall be treated as one course/subject for re-evaluation
- Provided further that a candidate who has already passed the examination shall also be allowed to apply for in re-evaluation in course/subjects if he/she desire so.
- The candidate applying for re-evaluation in the subject having already passed but fails to secure a pass in re-evaluation is declared to his result/marks.
- A candidate having applied for re-evaluation in failing subject but does not secure a pass No changed is effected to his result/marks.
- The candidate will be awarded average of the marks awarded to him by the first examiner and the second examiner in the papers or subjects applied for re-evaluation.
- Subject to the revision from time to time, the fee for re-evaluation shall be Rs.500/-per subjects/papers.
- 9. Where the result of the candidate improve by 15% or more marks after re-evalvation. The 50% fee will be refunded to the candidate by the College, on submission of the prescribed application form for refund of fee by the candidate.
